Prerequisites of Candidate

1. A Rotarian in good standing.
2. Ready, willing and able
 - To act independently in the best interest of FRCS.
 - To serve as an Office Bearer or as a Chair of a standing/working committee.
 - To attend a minimum of two-thirds of Board and General Meetings. (Attendance is recorded and published in the Annual Report)
 - Only candidates approved by the Nominations Committee are eligible to stand for election.

Notes on Nomination

1. Only members (Rotary Clubs) duly admitted to FRCS by the Board shall be eligible to nominate candidates for the vacancies of Directors.
2. Candidate must be a Rotarian.
3. Candidate need not be a member of the nominating Rotary Club.
4. Candidate must furnish his/her up-to-date Curriculum Vitae.
5. Under Article 32(c) of FRCS Articles of Association, the retiring Directors are eligible for re-election to a further term of 2 years.
6. Members may nominate any number of candidates or may decide not to nominate any.
7. Members may nominate multiple candidates for each vacancy.
8. Members may nominate the same candidate for multiple vacancies.
9. Use 1 nomination form per candidate.
